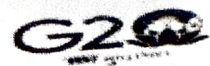





**REVISED SCHEME FOR RESIDENTIAL EDUCATION FOR
STUDENTS IN HIGH SCHOOLS IN TARGETED AREAS
(SHRESHTA) (FROM 2022-23 TO 2025-26)**

1. OBJECTIVE

1.1. Providing quality education and opportunities for even the poorest is the Constitutional mandate. The students from the Scheduled Caste communities, for long been subjects of untouchability, were kept out of quality education; a situation that perpetuates the disadvantages carried forward for generations of discrimination. The Governmental efforts to spread educational facilities without discrimination have worked well in achieving near universal access. However, the objective of providing access to quality education that provides a level playing field, is still far from reality. The scheme for Residential Education for Students in High Schools in Targeted Areas (SHRESHTA) has been conceived to provide access to high quality education to the students from Scheduled Caste communities.

1.2. The objective of SHRESHTA is to enhance the reach of development Intervention of the Government and to fill the gap in service deficient SCs dominant areas, in the sector of education through the efforts of grant-in-aid institutions (run by NGOs) and residential high schools offering high quality education and to provide environment for socio economic upliftment and overall development of the Scheduled Castes (SCs). The Scheme is further modified to provide easier access to the bright SC students in the best schools in the Country, thereby securing their future opportunities.

2. Modalities of operation

The scheme would be implemented in two Modes:

**Mode 1: SHRESHTA schools
(Best CBSE private Residential Schools)**

2.1. Under this, each year a specified number of meritorious SC students in States/UTs will be selected through the National Entrance Test for SHRESHTA (NETS) to be conducted by the National Testing Agency (NTA) and admitted in the best private residential schools identified based on the database of the CBSE in classes 9th and 11th for completion of education till 12th standard.

Thereafter, the students may be connected to Post Metric Scholarship Scheme or Top-Class Education Scheme to continue their further studies with adequate financial aid.

2.2. This component (Mode-1) shall be operationalized as per the following details:

(1) Selection of schools:

- a) The best performing private residential schools affiliated with the CBSE will be considered based on parameters such as: existence for at least 5 years, having more than 75% pass percentage in Class 10 and 12 in the last 3 years, and having adequate infrastructure for admitting additional atleast(10) SC students in classes 9th and 11th classes (together).
- b) A Selection Committee under the Chairmanship of Joint Secretary (in-charge of the scheme), a representative of CBSE and the Director Internal Finance Division in the Ministry would finalize the selection of these schools in January every year.
- c) The schools so identified (hereinafter called as SHRESHTA schools) will be registered in the e-Anudaan portal along with the required school details and account details which shall be duly verified using the PFMS system.
- d) School being funded by central Government (like NVS/EMRS (under 10% quota)/KGBV/State Govt. school etc.) including the schools covered under the scheme which have been funded under PM-AJAY/Samgra Shiksha Scheme of DoSEL shall not be covered under this Scheme.
- e) No school being supported under Mode-II of the scheme, shall be funded under Mode-I in respect of the students enrolled from the FY 2022-23 onwards.

(2) Selection of students:

- a) Eligibility:
- i) Only SC students studying in the recognized schools – Private or Government or Local Body schools are eligible for the NETS.

- ii) For admission in the Class 9, the student should have passed the Class 8 in the academic year immediately preceding the year of admission.
- iii) For admission in the Class 11, the student should have passed the Class 10 in the academic year immediately preceding the year of admission.
- iv) The parental income shall not be more than Rs. 2.5 lakhs per year.
- v) The Caste and Income certificates shall be uploaded prior to the web counselling.
- vi) Students applying under this Scheme should not be covered under Pre-Matric Scholarship Scheme of the Department

b) National Entrance Test for SHRESHTA (NETS):

- i) The admission in schools would be based on the merit as obtained in the nation-wide merit test the "National Entrance Test for SHRESHTA (NETS)".
- ii) The NETS would be conducted by the National Testing Agency (NTA).
- iii) The test would be a computer-based test conducted all over the County.
- iv) The selected students would be offered choices of the SHRESHTA schools.
- v) For exercising this option, a web counselling system shall be developed by the NIC. In order to ensure that all the seats are filled, there may be multiple rounds of web-counseling.

(3) Number of seats:

- i) The tentative number of seats for each year up to 2025-26 would be as follows:

- ii) The seats would be shared between the SHRESHTA schools by December each year for the following academic year.

(4) Admission:

- i) Once the option is exercised, the school would automatically, and without any further test, admit the student.
- ii) The fee for the student covering the school fee (including tuition fees) and hostel fee (including mess charges) would be released directly to the schools by the Ministry within 30 days from the date of confirmation of admission on the IT portal.
- iii) The school should provide hostel facilities for the students and provide necessary assistance for the students to settle down in the new environment.
- iv) The school may designate one of the teachers as the Counsellor, who would resolve the difficulties faced if any, by the students.
- v) The students admitted in Class 9 or 11, including the students admitted during the F.Y. 2021-22, shall automatically be funded for the next classes till they complete 12th class, subject to passing the exams of the previous class.

(5) Bridge Course:

- i) To ensure that the SC students so admitted can catch up with the rest of the class, a Bridge Course may be conducted by the school covering the topics given in Annexure-1.
- ii) The bridge course should be conducted outside-the-school-hours after identifying the individual academic requirements.
- iii) An amount of upto 10% of the annual fee can be provided separate under the scheme.
- iv) The bridge course can extend upto 3-months or as required by the student.
- v) Bridge course will target at enhancing the capability of the student to easily adopt to the environment of the school.

(6) Scholarships for students:

- i) The scholarships for the students will cover the School Fee (including tuition fee) and Hostel Fee (including mess charges) subject to a maximum limits as given below:

- ii) The scholarships will be released in one installment directly to the account of the schools through online process using the e-Anudaan portal of the Ministry.
- iii) Release of the scholarship for the following years shall be subject to furnishing of Utilisation Certificate as per GFR provisions.

(7) Monitoring:

- i) The progress of the students would be monitored by the Ministry from time to time.
- ii) In case any student leaves after getting admitted into schools and payment of fee to the school, it should be brought into the notice of Central Govt. immediately and fees paid should be refunded to the Consolidated Fund of India.

Mode2:NGO operated schools

(Guidelines hereinafter applicable only for Mode 2 of the Scheme)

3.1. Schools/Hostels run by VOs/NGOs and other organizations having higher classes (upto class 12) and who have been receiving Grant-in-aid will be continued, subject to satisfactory performance. The NGO-run primary schools would be given time for upgrading into High Schools before 2025, failing which they may not be supported under the scheme.

3.2. The NGO-run schools being given grant-in-aid must maintain good academic quality, have adequate infrastructure, shall have recognition of the State Government and affiliated to State/Central Board. Failure in any of these essential prerequisites would entail cancellation of the grant-in-aid.

3.3. In order to be eligible for assistance under this Mode, an organization should meet the following conditions:-

- a. Organisation should be:-
 - i. Reputed school chain, CSR foundation, Reputed organization etc., who are running good quality schools recognized by the State Govt. and affiliated to State/Central Boards, or
 - ii. Any other organisation of repute, which may be approved by the Secretary, Department of Social Justice and Empowerment.
- b. The organisation should have been registered and should be working in quality school education.
- c. The organisation shall have a properly constituted Managing Committee with its powers, duties and responsibilities clearly defined and laid down in a written Constitution; it shall have an appropriate administrative structure and a duly constituted Managing/Executive Committee.
- d. The organisation is initiated and governed by its own members on democratic principles.
- e. The organisation shall be a non-profit entity.
- f. The organisation should have its own website for pro-active disclosure of the information, as far as possible.

3.4. Under this Mode, grants shall be sanctioned in favour of the organization(s) subject to prescribed financial norms and terms& conditions as stipulated and revised from time to time by this Ministry.

3.5. The grant shall be sanctioned in accordance with and as per the procedure laid down under General Financial Rules, 2017 as amended from time to time. The Ministry will issue the sanction order in the name of the President/Secretary and transfer the funds to the bank account of the organization which should be under joint operation. If the headquarter of the organization is not located at the project site, the funds will be in turn transferred by the organization into a bank account at the project location to be jointly operated by the Secretary and a duly authorized project head within 7(seven) days from the date of receipt of funds. For this purpose, the organization shall open a bank account in the name of organization at the project location also.

3.6. The grants under the Scheme will be provided for School fee and residential charges for the SC admitted in the schools with a condition that if other than those are admitted, the school shall be allowed to collect the fee from such students. The grant per SC student shall be as below:

While calculating the eligible grant, the attendance in the U-DISE would be taken into account.

(*Calculation/justification in this regard is given at **Annexure-3**)

3.7. Funds will normally be released through electronic transfer directly to the bank account of the organization as referred in sub-para above.

- i. Organisations having presence in more than one State and having more than one branch will be eligible to receive for each of its branches grants for meeting expenditure on administrative overheads involving supervision and monitoring of the performance of its various branches. Each branch can apply separately or under the parent body.
- ii. The total annual grant shall be released in one installment before **30th of June** every year, after a physical inspection of the functioning of the school in April to June every year.
- iii. The organizations shall be eligible to receive non-recurring grant after every 5 years. (as per **Annexure-2**)
- iv. The grant-in-aid shall be released after the grantee organization executes an Agreement Bond in prescribed proforma to the effect that in the event of its failure to abide by any or all the conditions stipulated in the sanction letter, it shall be liable to refund with

interest thereon whole or such part of the grant as the Government of India may decide.

- v. Sanctioned strength of the ongoing project can be enhanced with the approval of the Secretary (SJE).

4. PROJECTS ELIGIBLE IN MODE-2

4.1. The existing institutions (residential schools/non-residential schools/hostels) which were found to be having satisfactory infrastructure as per inspection conducted by this Ministry/PMU and conforming to the conditions of the scheme shall be continued. The institutions which do not conform to the new guidelines shall not be given any grant w.e.f. next financial year.

4.2. The performance parameters and standards of Mode-2 organisation(s) for continuation of grant-in-aid are/will be as under:

A. Infrastructure

- i. Class rooms @ one room for each class/section.
- ii. Sufficient number of benches and desks (or chairs and tables) for sitting all the students.
- iii. A decent cot and bed @one for every child.
- iv. Light and fans for every class room and residing rooms.
- v. Residential schools/ hostels for girls must have female service staff, wardens and chowkidars, and adequate security provisions.
- vi. Toilet/bathroom@ one for every 10 children. Toilets and bath room should always be kept in clean and hygienic condition.
- vii. Hygienic Kitchen& dining room.
- viii. Nutritious and sufficient food to be given to the student trice a day. Record of the same must be maintained up-to-date.
- ix. Clean and safe drinking water facility to be provided to the students.
- x. Doctor should visit the school and hostel regularly. Record of Doctor's visit must be maintained up-to-date. First-aid-boxes and all emergency medicines, etc. must be kept in both school and hostel for any exigency.
- xi. The students will be given 4 sets of uniforms (including shoes) in a year. The record of the purchase and distribution of uniforms will be maintained up-to-date.
- xii. Games and sports facility, physical education, yoga, etc. and a playground for games and sports must be made available to the students.
- xiii. Installation of CCTVs and linkage of CCTVs with website for live streaming.
- xiv. Aadhaar based attendance system that can be integrated into a

central portal.

- xv. The school must have the recognition certificate of the Education Department of the State Government. In case of High Schools, the school must be affiliated to the State/Central Board of Education.

B. Standards:

- a. The 10th class and 12th class pass/mark percentage shall not be less than average Board result of the State/Central Board.
- b. The teachers engaged shall be qualified and well trained in place as per standards of State/Central Board.
- c. The teachers in High Schools must be at least graduates in their respective fields with B.Ed. qualification.
- d. Physical Education Teacher/ Yoga Teacher must have passed the PET training from a Sports/Yoga Academy.
- e. Similarly other warden, staff cook, helper, aya, sweeper, peon, guard, etc. should have necessary qualification and experience as per their trade.
- f. The number of teachers shall be as per the standards of State/Central Board. In any case their number must not be less than 6 in a school and not less than 2 in a hostel.
- g. The honorariums to the teachers and other staff who are working fulltime must be paid in time as per the minimum rates prevailing in the district for similar jobs.
- h. All records and documents must be maintained up-to-date and shown to the inspecting team and the audit team as and when required.

4.3. Change of Location of the Projects: Change of location of the projects shall be approved by the State Government/ UT Administration under intimation to this Ministry. However, the selected location should be within the location criteria spelt out in the Scheme guidelines.

5. Procedure for application of grants in Mode 2:

- a) The e-Anudaan portal would be opened on 1st April every year for entry of the renewal students; and would be kept open till 30th June for entry of the fresh students. The school shall enter the details of the students in the database of e-Anudaan.
- b) There shall be a physical inspection of the schools in June every year by the PMU of the Ministry.
- c) NGOs/VOs shall apply online on the e-Anudaan-portal of this Ministry i.e., www.grants-msje.gov.in. along with all the required documents viz:
 - i. Utilization Certificate of the grant last released, in the format prescribed under GFR- 12A. Audited / Unaudited

accounts for the previous year indicating the expenditure incurred on each sanctioned item vis-à-vis the grant sanctioned. The UC submitted as per (b) above, should clearly indicate three items in the heading

1. Project specific ID given by DoSJE,
2. Name and location of the project, and
3. Name of the NGO/ Organisation as per the Template (attached herewith).

ii. Budget Estimates for the financial year for which the grant-in-aid is required; and

iii. Annual Report giving Performance, with statistical data, of the projects during the previous year.

d) As per provisions of rule 230(8) of GFR, 2017, all interest or other earnings against Grants-in-aid or advances released to any grantee institution should be mandatorily remitted to the Consolidated Fund of India immediately after finalization of accounts.

e) Applications from NGOs /VOs in the prescribed proforma shall be submitted /forwarded / recommended by the State Government / Administration of the Union Territory on the e-Anudaan portal of this Ministry (<http://www.grants-msje.gov.in/>). In case the State/UT recommendation is not received before 30th June, such cases shall be considered on the basis of the physical inspection by the PMU for the purpose of release of grant.

f) The grants would be released in one installment by 31st July each year.

g) Use of EAT module of the PFMS is mandatory for all the organisations.

h) The implementing Agency shall, before it receives assistance from Ministry of Social Justice & Empowerment, execute a bond in the prescribed proforma. The transfer of funds would be done only after acceptance of the Bond by the competent authority in the Ministry. However, in respect of on-going projects, the application for release of funds should accompany with the bond executed on the above lines.

6. EXPENDITURE AND ACCOUNTS (for Mode 2 only)

- i. If actual expenditure on the items for which assistance was sanctioned falls below the level at which the grant was determined, the organization shall be liable to refund unutilized portion of the grant to the Government of India or the unutilized portion of grant shall be adjusted against the grant admissible for the subsequent financial year.
- ii. An aided organization must exercise reasonable economy in the

- expenditure on the approved items.
- iii. An aided organization shall maintain separate accounts of the grants received under this scheme. These shall always be open to check by an officer deputed by the Government of India or State Government. These shall also be open to check by the Comptroller and Auditor General of India at their discretion.
 - iv. An aided organization shall maintain Register of Assets in the proforma prescribed under GFR wherein all assets of permanent value and machinery and equipment having a life of not less than 5 years and costing Rs.10,000 and above (each item) should be entered.
 - v. After the closure of the financial year an aided organization will submit audited statement of accounts with utilization certificate for all expenditure incurred.
 - vi. An aided organization will also submit to the Ministry of Social Justice and Empowerment a statement in the proforma prescribed under GFR, 2017 showing the equipment/ machinery/ furniture purchased, with its price, out of the grant-in-aid received.

7. MONITORING

- a) All institutions which are receiving grants-in-aid under the Scheme shall proactively disclose the performance on their website and also on the e-Anudaan/ online portal. This portal shall allow updating of the information on all the given performance criteria at regular intervals.
- b) A real time Data Management Information System (MIS) for collection and dissemination of progress of the scheme will be put in place for better reporting on output outcome indicators. The MIS of the scheme will be linked through API to 'Output Outcome Monitoring Framework'(OOMF) Dashboard.
- c) In every institution there shall install closed circuit cameras from where live feed shall be available. The right to view this can be restricted in specific cases.
- d) All the organisations which are sanctioned grants-in-aid are expected to give correct figures about their performance. The institutions are liable for a field visit by an inspection team constituted for this purpose. Based on the inspection report, a decision could be taken for continuation or otherwise of grants at any time.

8. OTHER CONDITIONS

- a) If an organization has already received or is expected to receive grant-in-aid from some other Governmental sources for the same purpose, an assessment of Central grant-in-aid will normally be

made after taking into account of grant-in-aid from other such official sources.

- b) No capitation or other similar fees or donation in any form shall be charged from any beneficiary. In case any fee is charged from the beneficiary, it must be shown in the statement of accounts to be furnished to the Ministry/prescribed agency so that the amount so raised could be deducted from the admissible amount of grant-in-aid.
- c) Financial norms for the projects wherever not specified under the Scheme would be decided by the Ministry on case-to-case basis.
- d) Financial norms for releasing the grants to the charitable companies licensed under Section 25 of the Company's Act 1958 under the administrative control of the Ministry would be decided on case-to-case basis.

9. PENAL PROVISIONS

- i. If it is found at a later stage that the organization had withheld or suppressed information regarding the grant-in-aid from other Government official sources or otherwise had given factually incorrect information, the grant-in-aid of the Government of India may either be cancelled or reduced and the organization may be asked to refund the grant already given with interest rate of 12% thereon and as per the Government guidelines issued from time to time in this regard.
- ii. Any organisation found to have given false information or indulged in unethical practices would be blacklisted and such blacklisting will also be communicated to NITI Aayog for removing the name of such organization from NGO Darpan portal.

Calculation/justification in respect of the cost per unit student under Mode-2

Till last financial year 90% of the operational costs (95% of cost in respect of the institutions in NE States and UT of J&K and UT of Ladakh) of the institutions (residential Schools/ non-residential schools/ hostels for primary/ secondary schools) were financed through the scheme. This included salary/ honorarium of staff, rent of the building, electricity and water charges, doctor's visit, medicines, sanitations, food and other consumables, books, stationery, sports equipments, excursion, CCTV installation and streaming, utensils, cots and beddings, benches & desks/chairs & tables, etc. The approved items had been indicated in the Appendix-I to Appendix-VI of the earlier guidelines.

A thorough study has been made of the grant being given to the existing institutions. Based on the grants being given to six different types of grantee institutions and available SC students in the said organisations, unitary costs per student have been found out (for different type of institutions).

By use of unitary cost norm (per student), the Appendices of the previous guidelines will be redundant. The scheme will be transparent. Manipulation of costs will reduce. The scheme will become more beneficiary oriented instead of becoming NGO/VO oriented.
